There are several safe and reliable ways to save you time so you don't have to wait in line:

**BTC PRE-AUTHORIZED PAYMENT PLAN**  
 This is the easiest way to pay your phone bill. You can have your BTC bill paid directly from your checking/savings account or major credit card. Simply fill out and return the attached form via fax [292-5297] or drop off to our Cedar Avenue Customer Service Centre.

**ONLINE BANKING**  
 Did you know that you can sign up with HSBC and Butterfield Bank and pay your phone bill online?

**AUTOMATIC TELLER MACHINE (ATM)**  
 You can also pay your phone bill directly from any ATM. Consult your banking institution to set up your BTC account for payment via the ATM.

**DROP BOX LOCATIONS**  
 We have four locations in Hamilton – Washington Mall next to Delta Airlines, one internal box and one external box at our retail store on 46 Cedar Avenue and the Hamilton Exchange on Washington Street. Drop boxes are also located at our Somerset and St. George's exchanges. Do not deposit cash in drop boxes – cheques only.
